

**THE LOCAL GOVERNMENT ACT 2003**

**Regulations made by the Black River District Council  
under sections 102(1)(a), (3) and (4) of the Local Government Act  
2003**

1. These regulations may be cited as the District Council (Fees for Classified Trades) Regulations 2006.
2. The fees specified in the second column of the Schedule shall be levied in respect of the corresponding classified trades specified in the first column of that Schedule.
3. The Regulations made by the Black River District Council under sections 103(2) and (4) of the Local Government Act 2003 under Government Notice No. 109 of 2005) are being revoked.
4. These regulations shall be deemed to have come into operation on 1 October 2006.
