### **REGISTRATION OF POTENTIAL SUPPLIERS/CONTRACTORS**

The District Council of Black River is currently compiling a list of suppliers who wish to be registered as potential suppliers of goods, services and works for the following items amongst others:

- IT equipment, consumables, maintenance and repairs
- Furniture and office equipment
- Children playground equipment
- Tools and equipment (mechanical saw, telescopic ladder, etc)
- Hire of backhoe excavator/loader, track excavator, skid steer loader and lorries
- Building/civil/electrical and other works
- Construction materials
- Maintenance and repairs of vehicles / spare parts
- Street lighting fittings/ electrical and electronic accessories and equipment
- Banners, flags, rubber stamps, sign boards, sign plates, panels, / trophies, cups, medals and shields
- Pest Control specialists
- Protective equipment
- Cleaning materials and equipment
- Catering services for reception and supply of meals/ cakes / juice / bottled water
- Legal services
- Scavenging services//lopping
- Security services
- Podium, tents with lighting, sound system, animator, magic and cultural show
- Supply and servicing of air conditioners, generators, incinerators / crematorium
- Advertising services
- Printing works / Stationery/ magazines
- Consultancy/Surveyors/Architects
- Insurance providers
- Cleaning of bare lands /public toilets/drains
- Desilting of rivers

The duly completed Registration form should be addressed to the Chief Executive, District Council of Black River, Geoffroy Road, Bambous or deposited at the Registry of the Council. **The closing date for registration of suppliers is Wednesday 30 April 2025 at latest 16h00**

The under-listed documents should be submitted along with the Registration Form:-

1. A copy of the Business Registration Card, Valid Trade Receipt, Certificate of Incorporation and VAT Certificate
2. All persons/companies registered at the Small and Medium Enterprise Development Authority (SMEDA) should submit copy of their Certificate of Registration
3. Consultancy firms and contractors operating in the construction industry should submit their Certificate of Registration with the Construction Industry Authority(CIA)
4. The category of suppliers/contractors should be clearly mentioned on the registration form together with appropriate certificate from the relevant authority
5. If the category of suppliers/contractors changes during the year, the Council should be duly informed

NOTE: The attention of the applicants is hereby drawn to the fact that the District Council of Black River has no contractual obligation towards them and this shall not entitle them to become exclusive providers of goods and services to the Council. Prices of goods/services should not be submitted at this stage. Those who are already registered as a supplier with the District Council of Black River need not register anew.
